#### PAY VIA PAYPAL!

New this month is the ability to set up PayPal automatically to pay your base charge each month.

- 1. Login into the clients only section at the OSI website, You can either go to the main site http://osioffices.com and click on the 'Clients Only' icon or go directly via http://osioffices.com/egroupware
- 2. Type in your username and password, if you do not know these email the manager: manager@osioffices.com
- 3. Once logged in, under the news section click on the link which says "View your bill and address on line"
- 4. On the OSI Account management page you can view and pay your bill directly via paypal or subscribe to pay a fixed amount each month. If you want to subscribe, fill in the amount next to the subscribe button and then hit Subscribe This will take you to paypal. For any ancillary fees that are run up, these can be paid separately via paypal or cash/check/credit card.
- 5. If you want to pay your bill directly, without subscribing, click on the link "View bill"
- 6. At the bottom of your bill click on the link "Check out with PayPal" Check out with PayPal"
- 7. This will take you to a page where it will confirm how much you want to pay. After filling out the "Pay Amount" field hit the "Check out with PayPal" link. This will take you directly to PayPal where you can finish your transaction.
