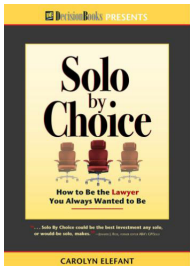

After scanning the mail will be resealed and put back into your mailbox. Please call or email the manager if you are interested in these capabilities.

The cost of SMS'ing will be \$.75 per message. After March 1st if you call in to check your mailbox the charge will be \$1.50 per call.
